## RENTAL AND UTILITY ASSISTANCE

### Coronavirus Aid, Relief, and Economic Security (CARES) Rent and Utilities Assistance Program

The Program provides one-time rental and/or utility assistance to eligible Palm Beach County residents who have experienced loss of income, reduction in hours, or unemployment as a result of the COVID-19 pandemic.

#### To be eligible, applicants:

- **Must be a resident of Palm Beach County**
- **Must provide documentation to prove loss of income, reduction in hours, or unemployment as a result of the COVID-19 pandemic**
- **Must provide documentation to show they have applied or are receiving state or federal unemployment benefits**
- **Must meet gross Area Median Income (AMI) limit not exceeding 140% AMI for the household**
- **Must have a lease and other utilities in their name or a household member's name**
- **Must not have received any other financial assistance for rent and/or utilities for the period payment is requested**
- **Must have less than \$5,000 in liquid assets in checking, savings, and cash card balances**

Assistance will be provided only for past due rents and/or utilities. The rent or utility due dates must be after March 1, 2020 and before December 30, 2020.
